The completed and signed form must be received by Euroclear Sweden AB no later than Friday 17 April 2026. The completed and signed form may also be submitted by e-mail and shall, in such case, be sent to generalmeetingservice@euroclear.com (state "Catena AB – poströstning").

Shareholders who are natural persons may also submit postal votes electronically through verification using the BankID security app via Euroclear Sweden AB's website <https://www.euroclear.com/sweden/generalmeetings/>. Such electronic votes must be submitted by 17 April 2026 at the latest.

- If the shareholder is a natural person who is personally voting in advance, it is the shareholder who should sign under **Signature** above. If the postal vote is submitted by a proxy of the shareholder, it is the proxy who should sign. If the postal vote is submitted by a legal representative of a legal entity, it is the representative who should sign.
- A power of attorney shall be enclosed if the shareholder postal votes by proxy. If the shareholder is a legal entity, a registration certificate or a corresponding document for the legal entity shall be enclosed with the form.
- **Please note that a shareholder whose shares are registered in the name of a bank or securities institute must register its shares in its own name to be able to vote.** Instructions regarding this are included in the notice convening the meeting.
- **Please note that the right to vote only accrues to shareholders who are entered in the share register maintained by Euroclear Sweden AB regarding the status on 15 April 2026, and notify their participation to Catena on 17 April 2026 at the latest, by casting their postal vote in accordance with the instructions in the notice convening the meeting.**

A shareholder cannot give any other instructions than selecting one of the options specified at each item in the form. If a shareholder wishes to abstain from voting in relation to a matter, kindly refrain from selecting an option. A vote (i.e. the advance voting in its entirety) is invalid if the shareholder has provided the form with specific instructions or conditions or if pre-printed text is amended or supplemented. One form per shareholder will be considered. If more than one form is submitted, the form with the latest date will be considered. The form latest received by the company will be considered if two forms are dated at the same date. An incomplete or wrongfully completed form may be discarded without being considered.
